 - \$65,700 registrations
 - \$26,700 donations
 - Total \$92,400
 - Expenses:
 - \$1,950.00 in travel expenses for speakers
 - \$0.00 Speaker fees
 - \$7,0811.36 Hotel fees
 - \$391.00 Other costs (marketing, supplies, etc.)
 - Total \$73,452.66
 - o NET Profit: \$18,947.34
- Note:
 - Registration costs are lower than hotel costs.
 - While donations and sponsorships can help the conference, the concern is the conference is not breaking even.
 - Request an increase in conference registration costs moving forward.
